- 8) Employed candidate should send their application through proper channel or to produce 'No Objection Certificate (NOC).
- 9) The candidate should fill the details in the hard copy of application form taking into account all the details of the educational qualification shown in the advertisement for the said post.
- 10) The prescribed educational qualification, age limit and other necessary qualifications mentioned in the advertisement will be considered **as on the last date of submission of application**.
- 11) The candidate should submit the original and self-attested copies of the mark sheet and necessary certificates from the Government recognized Board/University/Institution as and when notified by the competent authority.

 - c) As per (b) above, when the marks obtained in the written examination (Part-1) are equal, the priority will be decided by taking into account the total marks obtained in the educational qualification graduation level.
